अगर हालिया मामलों पर नजर डालें तो कारोबार अलग करने के कदम शेयरधारकों के हक में नहीं रहे हैं। इसके जरिए शेयरधारकों के लिए आकर्षक कीमत सामने आने की उम्मीद की जाती है।

साल 2017 के बाद अब तक अलग हुए सात कारोबार में से छह निवेशकों के लिए कीमत के लिहाज से विध्वंसक रहे हैं। अभी इन इकाइयों का संयुक्त बाजार पूंजीकरण कारोबार अलग होने के मुकाबले करीब 84 फीसदी नीचे है। इक्विप्रॉमिक्स के संस्थापक व प्रबंध निदेशक जी चोकाविंगम ने कहा, प्रवर्तकों की बिकवाली से सामान्य तौर पर डर पैदा होता है, खास तौर से कारोबार अलग करने जैसे कॉरपोरेट घटनाक्रम के बाद। यह महसूस कराता है कि नए ढांचे पर प्रवर्तक का भरोसा नहीं है।
